

## PRIVACY NOTICE

This privacy notice specifically refers to our use of data collected in relation to the **STEER NET ZERO BY 2030 - FACT OR FICTION? WEBINAR (the “Webinar”)**.

### Purpose of the data collection

The purpose of the data collection is to allow individuals to register to join the Webinar, which is aimed at educating and raising awareness of issues connected with de-carbonisation. ### Lawful basis for processing

We process your personal data on the lawful basis of our legitimate interests in marketing to our clients and potential clients, and in relation to providing the Webinar for the benefit of attendees. We will ask for your consent to be contacted by us in relation to events and promotional activities other than the Webinar.

### Direct marketing

We may use your contact details to send you marketing materials, provided we are permitted to do so by law. You always have the right to unsubscribe from any marketing. You can do so by contacting us directly using the details below.

### Who we share your data with and why

LogMeIn which owns and administers GoToWebinars. LogMeIn may send or host data outside the EEA. LogMeIn has entered into the EU standard contractual clauses with Steer which requires them to provide similar protection to personal data, as we are required to provide under UK law.
